# Parking and traffic regulations ACHEMA 2024

## Registration

Exhibitors, stand construction companies and freight forwarders must register in advance online, allowing them to easily download and print their own registration confirmation form: <https://gateway.messefrankfurt.com> You can drive to the specified Check-In with this registration confirmation form. Please follow the signs. The registration information will be scanned in at the Check-In. As soon as a loading zone becomes available, you will

be given an authorisation form allowing your vehicle to enter the exhibition grounds.

**Please note: In case of high volume of traffic waiting times are possible at the Check-In!** All vehicles must depart the exhibition grounds as soon as they have been unloaded/loaded. Vehicles that stay longer than permitted may be towed away at the owner's expense. [back](#)

## Parking spaces

Parking spaces are available for cars up to 2.5t gross vehicle weight and car trailers for a fee. Please reserve these at the latest 4 weeks before the event in the [ACHEMA exhibitor portal](#).

A very limited number of parking spaces for trucks are available for a fee at Rebstock. A reservation is not necessary here. [back](#)

## Set-up

### Advanced set-up 1 – 2 June

Please note that it is not possible to **register** vehicles until confirmation for advance set-up has been received.

### Set-up 3 – 9 June

**Registration** required.

\*Between 10 p.m. at night and 6 a.m. in the morning the time limit is lifted.

## Trade fair

### Deliveries during trade fair 10 – 13 June

For deliveries, vehicles will be granted entry via the gate closest to the exhibition hall for one hour in return for a deposit of €100.00 in cash. All other vehicles will only be allowed to enter with a valid parking permit. [back](#)

### Last day of the trade fair 14 June

- Entry will not be permitted after 12 noon
- From 12 noon until the start of admission for dismantling vehicles, no vehicles will be allowed to enter the exhibition grounds
- Please head to the E1 assembly point at the Rebstock car park. This is the only place where you can obtain a dismantling vehicle pass. [back](#)

### Admission for special dismantling vehicle pass 14 June, 4:00 – 6:00 p.m.

for exhibitors, for the transport of smaller loads by cars and vans up to 3.5 t gross vehicle weight rating. Pre-ordering is not possible, but a max. of 400 of these special permits are issued. The special dismantling vehicle pass will be issued at the information counter in Hall 4.C.

We require the following for the special dismantling vehicle pass:

- Presentation of a exhibitor number
- Presentation of the exhibitor pass
- Signing a declaration that you will be charged an additional €200.00 when invoiced for your ancillary costs by Messe Frankfurt if you leave the exhibition grounds after 6:00 p.m.

## Dismantling

### General admission for dismantling vehicles 14 June from 6:30 p.m.

Please drive your dismantling vehicles (only up to 7.5 t) straight to the designated dismantling assembly point at the Rebstock car park (E1). This is the only place you can receive your dismantling vehicle pass to enter the exhibition grounds, and it is the only place where police will permit and direct entry starting after 6:30 p.m. Access from other streets will not be granted until all of the vehicles from this area have already entered the exhibition grounds. It is only after this has occurred that cars from the car parks on the exhibition grounds will also be permitted to drive to the halls.

**Attention:** For the last day of the trade fair and the dismantling entrance no registration is necessary.

**By 2 a.m. all vehicles must have left the exhibition grounds due to the Empties Night.**
